

CORRUPTION IN WOLESI JIRGA IMPOSSIBLE INVESTIGATION

Meanwhile, member of the Wolesi Jirga proposed Dr. Ramazan Basharodest that the Wolesi Jirga has ratified a draft that would immediately be released by the judicial and judicial institutions and the lawyers of the lawyers who have legal offenses.

Humanitarian also said about the capacity of this draft that lawyers should only be able to express their views and to be able to vote.

These statements are present while reporting such reports that some of the MPs of the Wolesi Jirga, sometimes some of those security personnel engaged in plotting, in security incidents, corruption and other crimes involved in crimes But then investigate because they are not entitled to law enforcement and if they issue the issue to the court; then it should still be eligible for the Wolesi Jirga.
